

- Ingredients — Aqua, Sodium Laureth Sulfate, Phenoxyethanol, Glycerin, Cocamidopropyl Betaine, Sodium Benzoate, PEG-4 Rapeseedamide, Citric Acid, Ammonium Lauryl Sulfate, Parfum
- pH — Skin-friendly 4.5
- Shelf life — Unopened: please check expiry date on the label. Once opened, use within 12 months.
- Storage — Keep between 0 – 25 degrees C during storage. Avoid direct sunlight. Keep dry.






