




Lather carefully and rinse thoroughly with clean running water.

- Ingredients — Aqua, Sodium Laureth Sulfate, PEG-4 Rapeseedamide, Cocamidopropyl Betaine, Sodium Chloride, Ammonium Lauryl Sulfate, Phenoxyethanol, Propylene Glycol, Glycerin, Citric Acid, Sodium Benzoate, Potassium Sorbate, Tetrasodium Iminodisuccinate. No perfume. No colour.
- pH — Skin-friendly 4.5
- Shelf life — Unopened: please check expiry date on the label. Once opened, use within 12 months.
- Storage — Keep between 0 – 25 degrees C during storage. Avoid direct sunlight. Keep dry.






