Fulfilment of the reporting contractor's obligation under section 5 of the Contractor's Liability Act for companies registered abroad.

According to the Contractor's Liability Act, if a foreign company is a party to a contract, the corresponding information referred to in section 5 (1) of the Act must be submitted with a registry extract or similar certificate in accordance with the legislation of the company's country of establishment or in another generally accepted manner. The attached table provides information, by section 5 of the Act, on which certificate or similar document, taking into account foreign legislation, can be considered, at least in the case of companies registered in the countries concerned, as an equivalent and reliable statement in the fulfilment of the customer's obligation to report.

If the foreign company has a business ID in Finland at the time of concluding the contract, the subscriber must find out the information on Finland and the company's home country in accordance with section 5 (1) (1) and (3) of the Contractor's Liability Act.
